Subject: Divorce appeal

Gentlemen,

It is clear that our history is one of disagreement on numerous issues. CPC has apparently been very supportive of my wife separating herself from me which I argued (http://kozlowski.org/Heartbreak) was contrary to scripture and General Assembly decisions. I still stand by that. I have now been informed that a member of your congregation, my wife, is planning on divorcing her husband. I am asking that you step in to prevent this.

Let me reiterate that there has been no sexual infidelity. Let me also refer you to the General Assembly's statement that I quoted previously (http://kozlowski.org/Heartbreak,PCA) "It is important to acknowledge that the view that —desertion in 1 Corinthians 7 cannot be made to refer to anything but actual departure from house and home and the view we have stated above are both extrapolations from the Scriptural statements." I never left my wife. My wife left me.

The issues have been financial and stress. In 22 years of marriage our average income has been a CPI adjusted \$70K. The problem has not been the average but the valleys. Some, but not all, of the valleys were due to my attempts to rebuild my once successful business. To that I plead guilty, but fail to see in scripture any license to support separation because of it.

I have put a lot of stress on my family because of the risks I have taken. Early on the risks were mostly financial and reputation. They have grown to be more serious. My work in privacy and autonomy has come under fire from many sources. Post our separation I developed rootless domain name technology (http://ShofarDomain.com) that is now functional. It has garnered numerous supporters since it thwarts the ICANN monopoly and pulls one thread from the UN's takeover attempt of the Internet. However, taking down a multi-billion dollar monopoly does not make friends and has run into difficulty. This is an area of stress.

The most significant stress comes from what I now call Matryoshka Communications (http://ShofarPortfolio.com/Matryoshka). This is a refined version of what had already caused stress in my family while we were together. I was hoping that the Edward Snowden disclosures would bring more people to the table since Matryoshka is a technical solution rather than simply another thing to rage about. Thus far I those that will communicate with me state that they will not get involved because they fear the state. I would rather recall Matthew 10:28. I remain convinced that to love my neighbor, and even more to love my family, I must do what the Lord has gifted me to do and act as a warrior in the field of technology.

I find it instructive that other people in the privacy work with casual sexual lifestyles, like Edward Snowden and Julian Assange, or outright homosexuals, like Bradley Manning and Glenn Greenwald, who have been willing to violate state laws are rallied around. While someone providing a solution and is seeking to be obedient to the Lord and is currently within the law is ostracized.

This is a stressful situation. However, as long as the Lord allows, I will not back down on this. I do not see any reason that my stand should translate into a separated family. I am one man launching a serious and realistic salvo against the UN, NSA, GCHQ and others rather than focusing on developing my 401K. I make no apologies for that.

I have also made and continue to make attempts to find employment. Several jobs have come and quickly slipped through my hands. I contend that this was not due to lack of effort or incompetence on my part. In many ways I have become damaged goods and it has been difficult to find employment in software or menial work. I am also limited to telecommute or something in walking distance due to car trouble (http://kozlowski.org/Photo-2012-08-29).

The above is really just details. The bottom line is I love my wife and children and do not want to see a divorce on our future. More importantly I believe that obedience to the Lord is for our family to be together. Not only has the separation caused additional financial stress, but causes serious damage to our children. Gentlemen you know there is no license for divorce here. I appeal to you not only to prevent the divorce, but to actively pursue our reunification. Silence on your part has not been supportive. I ask that you break that silence.
