Family and anyone else,

This is an intensely personal, but a very serious request by me to you. This email has a long BCC list and I am more than willing for you to share it.

I have started to put voicemails and videos that have been done over the last few years online at a private URL that I won't be direct here since this email will be scraped. As you would be familiar with a URL like "www.EsystemSouth.com", use "Kozlowski.org" but put "Family" where the "www" would be. Sorry to be cryptic, but our government and corporations (redundant) scrape emails and makes use of them. I want to make it a bit less likely, at least by my actions. The site is early in layout, but some things are there that I hope will be useful.

In particular on Nov 14, 2016 I did a video specifically directed to Jim Cross, Sr. and challenged him that what he was doing was unloving to my family and me. I offered grace, specific exposition of Scripture, and another appeal to reconcile. He has yet to return to the table.

The video ("/2016-11-14") is online. Please consider viewing, downloading, and even sharing it with whomever is appropriate. This is not an effort to belittle Jim Cross, but to reopen the door of communications. Since he remains silent, I am appealing all the louder. Please set the question before him why does he not communicate with me. Ask him if any part of my exposition of Scripture was wrong. Even more ask him if any part was right and is he following the Scripture. Additional videos on this subject include Mar 16, Apr 29, and May 20 of this year.

This is not a game, nor is it a trivial request I am asking of you. It remains my desire to reconcile with my family, and there would be a wonderful start if Jim Cross and I could do so. He does not respond to my requests. Please ask him to. Please point out to him that grace is being offered by his son-in-law. Please ask him to make use of it. The role model set before my kids is to bow to the state rather than the Lord. This sinful man, by the grace of the Lord, is attempting to bow before the Lord and reflect that by loving my wife, my kids, and Jim Cross. Please help me do so.

Perhaps the most significant video I have ever done is "Naming Names" ("/2017-02-25") that is on the site. I hope you will see grace in it. Since it has been seen by others already, I plan on making an edited version of it, masking the names, and putting it on the public Distinctivist.com site. Please correct me where I am wrong, but I contend that this video shows grace. Thus far no one mentioned has even acknowledged it.

If you do nothing else, please download and view the "Naming Name" video. It is 32 minutes long, and I hope you will find it time well spent. In many ways it was and is the Lord's gift to me. The attitude expressed is not my nature, but solely the Lord's grace. I hope you will see that in the video.

After almost 5 years of being cast out, being a "**brokenhearted old man basking in the grace of the Lord**", I continue to seek to be "**Broken Together**" with my wife. My emails, phone calls, and videos are blocked between my wife, kids and me. I contend this is in violation of man's law and the Lord's commands. Please share this with them. Please let me know.

Can you imagine what a joy it would be to my kids, my wife, extended family, and myself if some or all of us were to reconcile, as the Lord commands? Please pray for that. If possible, please be a part of that.
