Mr. Cross,

Thank you for taking the time to respond to one of my numerous emails. It is worth noting that you have not responded to emails to you, but to one addressed to my kids. It should be easy to see to anyone who has read the emails between us or viewed the videos now online that you are taking my words and trying to use them as an attack on me.
