Greetings,

There have been numerous dialogs with many, except from all but one of the principles. However, because of the tone of some people I felt compelled to discuss "Marriage, Divorce, Remarriage, Adultery, Mercy" that you will find in the attached 12 minute video. It is my hope you will find it compelling, accurate, and loving. It took a while to research and produce the video, and there was a lot of dialog with multiple parties this week, so there is little on the reconcile issue or institutional church issues. However, please consider asking the institutional church leadership, face-to-face, via email, or via phone, if any of my claims from Scripture are correct. And if so, why do they not contend with me on them? Why do they not pursue reconciliation? Why do they continue in the institutional church?

Remember the challenge on marriage in "<u>Jim Cross - Interpret Scripture with Scripture</u>". Ask them why they don't address it.

Remember my challenge to the institutional church in "<u>Challenge to Covenant Presbyterian Church</u>". Ask them if my case is valid? And if <u>you</u> think it is valid, do you still tithe to the institution?

Remember my challenge to the position of elder in the institutional church in "<u>Institutional Fraud</u>". Ask the leadership why this is not correct, and if it is, why they remain in their position?

Remember my challenge to appear before the congregation on Sunday morning to face my accusers remains on the table. What has occurred this far is cold-blooded execution! Perhaps the Biblical model of contention "before them all" is more appropriate. I remain willing. Ask the leadership why aren't they willing?

Remember that this is not a game or a trite effort. Just the large scale of the http://Family.Kozlowski.org site should make that clear. I am a follower of the Lord Jesus Christ, and it remains my contention that those who are claiming to proclaim the gospel are using another gospel (2Co 11:4).
