In the attached 13 minute video an effort is made to give examples where dialog on a noted issue is flooded with sensationalism and misinformation to turn us into mush. The point is that we do the same with the Scripture, and more often than not the perpetrators are those whose livelihood is based on our dependence on the institution rather than the Lord.

An offer is made for one-on-one dialog with the congregation, rather than the leadership. As a member of the congregation, you still have a responsibility before the Lord to follow Him. If I am right, are you a member of a cult?

Have you asked them directly, as I have asked previously? I remain more than willing for any to have a direct conversation with me, but thus far they have stayed behind their institutional fortress and turned to the state as it appears Mat 5:24, and 1Co6 is not relevant in their world. But I will continue to try. I remain willing for to fully reconcile with any.

My past is littered with an effort to have the world and the Lord. I was wrong. I am now attempting to follow Paul's model in Philippians 3 and count the world as rubbish. Consider the rest of the chapter, and I ask you to ponder if it applies in your life.

While no hope is offered in return by the institution, extended family, and those I love dearly, I will continue to pursue reconciliation, and do so openly. I do so trusting in the Lord, in obedience to Him, and in hope that others will gain from my effort. I am encouraged that this has occurred. Please encourage me if you are also one of them.
