Subject: Continued and more public pursuit of reconciliation

Mr. Cross,

I stated that I would be going more public. In the last few days I have availed myself of opportunities to do so. Some of the videos from the Kozlowski.org site are now available at <https://www.real.video/channel/kozlowski>. They have yet to be promoted, but since the site is fairly new, I am often on the home page and there have been views. Other videos are being prepared to follow. They are on YouTube as well.

Thus far the **“Marriage, Divorce, Remarriage, Adultery, Mercy”** video has been the most popular. Can you show me from Scripture where there is an error in my exposition?

I just released **“Preparing our kids to contend”** and was surprised to have two views within the hour it was released. Perhaps others are interested?

The just released **“Do not compromise”** is currently on the home page. This was recorded two years ago, but my family has made no comment.

I have discussed with others if I should also publish **“A bit of my history - You cannot serve God and money”** (<http://kozlowski.org/2018-01-15+1>). Clearly we don't agree on Mat 6:24, but I still take it for what it says. Should this be published?

Also being discussed is **“My Move and Reconciliation Plans”** (<http://kozlowski.org/2018-03-25+1>) which mentions you by name. You have any thoughts on this?

The **“Reconciliation in Syria, why not in the US?”** (<http://kozlowski.org/2018-04-10+1>) is only 3 minutes and I wonder also about that.

What is clearly about twice as popular is the ShofarNexus channel (<https://www.real.video/channel/shofarnexus>).

Consider the **“Your privacy is lost – How it is done”** video (<https://www.real.video/5811846640001>). Do you have any idea the price I pay in the corporate community by the content of this video? Do you see how I have cut my throat? However, isn't that what a follower of the Lord Jesus Christ should do? If not, could you point that out from Scripture?

I have been having a delightful and serious dialog (that word is in the dictionary) with a gentleman in Texas who uses Christian language but thus far refuses to claim Jesus as Lord. When I challenge him on 1Peter3:15, he simply ignores it, but at least the dialog continues. If you check, 1Peter3:15 is probably in your Bible too. It is a command, and you have been asked. What does the absence of a reply mean? If you are right and I am wrong on the Scripture I have presented, doesn't 2Tim4:2 put the weight on you? You don't seem to think Mat5:24 means what it says, so clearly these are rhetorical questions.

Clearly I don't expect an answer from you. When I sent you the book, as described in "**Jim Cross - Scripture Alone**" (<http://kozlowski.org/2018-03-04+1>), you remained silent. So I don't expect anything to change. But my hope remains, even without my expectation.

My hope remains, because I am a follower of the Lord Jesus Christ. One of the characteristics of a follower of Christ is described in 2Tim3:16, the willingness to correct and be corrected. I set before you the evidence of that characteristic. When you are willing to do the same, I am here and willing.
