Dorothy-Jane,

First and foremost, my goal of reconciliation remains as I state in my voicemails five days a week that I am a follower of the Lord Jesus Christ, I love you and I want you back.

A notice was received from the state of Tennessee that explains the seizure of \$184.88 from my checking account last Wednesday. You may be unaware that Monday I finally took care of rent issues and had planned on restarting payments to you in the following week or two. This was stated in voicemails and emails.

The terms in the notice are less than ideal and I will have to contact the state to resolve this. My concern is that if evidence is required, it may put you in a bad light. Yes, I am behind with you and that has been mentioned more than one in voicemails and email. But this will also open the fact that I am still paying for Julia who already has two kids of her own, and I have no idea about George.

The refusal to allow me to speak with our kids for three years may also come up as the evidence is online and blatant. This may have repercussions that neither of us want.

Therefore, do you want to see if you can take care of this issue before I do? If so, at least acknowledge this email. I will otherwise contact the state Wednesday or Thursday. I do not contact them on my own volition, as 1Co6 requires, but they contacted me and I have not choice.

Let me state again that my plans were to start on August 12 or 19 paying \$333 per week to start to catch up. Because of what happened on August 7, plans changed. On the 12<sup>th</sup> I prepaid \$350 toward September rent and plan to do that next week also to preclude difficulties for me. As of this morning I was pondering an updated plan of \$222 a week starting in September which would stop me from getting more behind. But for now that remains flexible.

For your reference I live cheap. I haven't had a car in 7 years, but I do have a real shoe expense as I walk at least 20 miles a week. There are no medical or insurance expenses. In the Lord's grace I do have a 1200 Sq. Ft. home/office that is very simple, but very quiet which is a must for my work. While I work with people in Georgia, India and Argentina, it is all telecommute, so again the expense is very low. So there is no concept of keeping for myself to deny you, but rather I have been diligently working on fulfilling Romans 13:8. It has been slow and is incomplete. To be honest, the focus has been with those who will communicate with me.

Unfortunately it seems pointless to again point to the Scripture as it is clear that at least those around you fulfill Matthew 23:3. The sound you hear is the gong of 1Co13:1. But then there is the man who loves you and you promised to love for better or worse. That man, me, still loves you dearly. If YouTube's statistics hold true with the "Marriage Defined and a Commitment Beyond" video that I did for your birthday, then at least a third of the 200+ views watched to the end. That is where the punch-line was. That is when I state my claim that it is you and you alone for all of the days of my life. I still live that and will live that. If the Scripture is true, then for your benefit you should too. If it is not

true, ignore it. But more importantly, if you love the Lord and you love me, as you once said you did, then please open again your heart to both of us. I am a flawed man, but I am your man.
