Dorothy-Jane,

I did some quick checking on old things about Wachovia and found where you paid \$177 in 2012 for some issue that remains unclear to me. I only vaguely recall this, but assume this was paid to protect your credit rating as we spent decades dealing with the world as one.

In the process I found an email from you to me on July 6, 2012 that had some familiar terms that is quoted below:

Hi My Man!

...

I love you!  
I love you!  
I love you!  
DJK

Do you remember when you and I would speak and write to each other in those terms? A week later you abandoned me. I still don't understand how that would be consistent with love.

The concern I have is that there is an American version of Sesame Credits which is the credit score. In China the cost of having a low score goes well beyond not being able to get a loan. This will grow in the same way here. Consider how I was always chosen for "extra security" when I took flights. I don't fly anymore, and that is why I drove to Baltimore in 2011 or Philadelphia in 2017.

I was very specific on the phone call yesterday that if I owe the money, send me a bill and I will pay it. I gave my email and street address, but assume it was ignored. The objective is intimidation, just like when Meadowview sent the police to my door. Those in power will use things, especially when they have something real they can point to, and amplify it to intimidate. They must keep people subservient to the institution.

An example I found humorous is when a model's photo on the side of a bus in China was seen by a camera and software behind it correctly identified the person and deducted from their bank account a fine for jaywalking. It is getting that ridiculous. And in China, there is no getting off the list of "untrustworthy".

If you respond to intimidation, as what may have occurred in 2012, you are training our kids to do the same. To set a model before them that anyone who claims to represent an institution must be immediately yielded to due to their claim of institutional authority, rather than presenting evidence of authority. You are molding our kids to be minions. Yes, obligations are to be met, but they are taken care of when evidence is presented, not due to a phone call with some vague authority that refuses to fully inform you for the basis of the claim.

Please set a model of a reasoned approach to dealing with the world and not voluntarily subjecting yourself to it. Show a model of courage and grace, not a model of being part of a clamoring crowd shouting "Hail Victor". Please set a model before our kids on what it is to be a follower of the Lord Jesus Christ, not a minion of the institution. Clearly, the evidence suggests that I should see no hope for this, but then there is the Lord's grace. May it flow abundantly to our family!

Because of the joy I found in reading your July 6, 2012 email and the reminder of the love I once saw from you, this email is being set to the voicemail list. I want all to remember that at one time we were seriously in love with each other and committed all of our lives to be together as one. My commitment remains and I earnestly seek the same from you as a reconciled family.

Dorothy-Jane, I seriously love you and want you back!

Dorothy-Jane,

It was very cold, non-informative, and overtly threatening. It seems like the way you have been with me. You have been cold, non-informative, and used the law to threaten me. I was told to expect the police at my door within the next 24 hours with a court summons if I don't pay.

Is this like Chris Bitterman thinking a man overtly trying to reconcile him is a death threat? It seems the Lord's ways would be much better, such as speaking clearly, openly and boldly. But at least this time I expect the police to bring something in writing, rather than just a verbal warning. Perhaps the reason the police representing Meadowview had nothing in writing is that seeking reconciliation isn't against even state law. That would be consistent with Gal 5:22-23, but then it was you that twisted Gal 5:1 and the man who loves you tried to offer correction. Perhaps the person who violated man's law is Chris Bitterman or his surrogate? But he has nothing to fear from me as I have read 1Co6, unless the Bible is true and violating Mat5:24 is an issue.

Dorothy-Jane, please remember me, the dad to your kids, the man you committed for better or worse to spend the rest of your days with, the man who is trying to reconcile his family, and it appears the only man around you who is looking

to the Lord first, rather than the state or the Talmud for guidance. Please open your eyes and see who really loves you. It is me, the one who is in constant appeal to the Lord for your blessing. I am the one seriously in love with you and by the Lord's definition should be at your side. Please remember that. It would be to all our family's blessing to live it.
