Subject:	Delightful dialog on Social Security

Mr. Cross,

It was a joy to have a dialog that went over two hours today on Social Security from the perspective of obedience to Christ. The stand I have made for many years now is that as a follower of Christ we must pay into the system, as is clear in Romans 13:6-7, but we are not to take any benefits from the system as it is theft.

I was challenged by a brother to back my claims who gave a bunch of "what about this" questions. I contend, that I am batting a 1,000. It is clear and easy to defend that the recipient of Social Security is a thief.

It is encouraging to me that my "**Obedience to Christ or Social Security**" video, which I did for my 62nd birthday, as I qualified for early retirement, is in my top 10 list on BitChute. I stand with that today and plan to do another in about 10 days as I will qualify for full Social Security and remain with the stand that I refuse to accept it as it is unloving and theft.

A corollary to this is that I have received a letter from the Federal Government stating that I "may" qualify for the various stimulus checks. Thus far I have received nothing and will not pursue it as it is also theft, and the victims are my kids who are being made debt slaves. This is easy to see with a study of history, especially in the monetary arena.

This concept was amplified yesterday as I did a half-marathon hike. In the process I did see five people who are currently recipients of Federal payments, most or all based on the Social Security system. I did not bring up the subject as it is for the follower of Christ, as 1st Corinthians 5:12 makes clear (*"For what have I to do with judging outsiders?"*). But then there are those who claim Christ.

What brought you to mind was comments I have heard from you, such as "you paid into it". Social Security is not an involuntary investment program for your retirement, but rather income transfer. It was so from the beginning in 1935 when the proclamation was made that "you will never pay more than 3.5%". That was not the first or last lie from the government. The example I use to make it clear is that if someone steals your car, does that give you the right to steal someone else's car?

Besides the logical arguments, there is also the underlying objectives, which can be clearly seen in the Communist Confession of Faith, which summaries destroying the family over generations. This is the purpose of things like the marriage tax credit as it put power in the hands of the state. It is the purpose behind inheritance taxes, which can be seen in plank 3 of Manifesto of the Communist Party "Abolition of all rights of inheritance." You also might find instructive section 21 of The Principles of Communism:

What will be the influence of communist society on the family?

It will transform the relations between the sexes into a purely private matter which concerns only the persons involved and into which society has no occasion to intervene. It can do this since it does away with private property and educates children on a communal basis, and in this way removes the two bases of traditional marriage – the dependence rooted in private property, of the women on the man, and of the children on the parents.

And here is the answer to the outcry of the highly moral philistines against the "community of women". Community of women is a condition which belongs entirely to bourgeois society and which today finds its complete expression in prostitution. But prostitution is based on private property and falls with it. Thus, communist society, instead of introducing community of women, in fact abolishes it.

Do you see that these concepts are embraced today? Do you see that by changing a few words to modernize or soften it, we are almost living it in full? Do you see the difference in the model set forth by Christ?

Do you still state you can trust the government and do license plate reading software? Do you still go out of their way to personally praise sheriffs for implementing traffic stops for drugs? Do you still reject someone who says NO, I will not bow to the state and has repented from his past? Have you consider repentance, or do you still trust the state?

I don't know if you have or are taking Social Security payments. If you are, you are a thief and one of your victims is me. While in just a few days I will be "qualified" as a taxpayer who has paid into the system As a follower of Christ I will never be qualified as Exodus 20:15 remains in effect.

I engage other brothers in Christ on this. As a brother in Christ, are you willing to engage me?
