Subject: Visit from the sheriff not wearing masks

Family,

Since this has been sent to many, it seems only appropriate that you should get it also.

Yesterday as I was preparing a smoothie I noticed a sheriff's vehicle coming down the driveway. I did grab my, pardon the foul language, iPad and starting a video recording. I went out to greet the gentleman in the car who never exited his vehicle during our interaction. Shortly afterward a second sheriff came down the driveway, a woman who did exit her vehicle and approached us to become part of the dialog.

The best news of all is that the two sheriffs were not wearing masks.

I was given a summons to appear in court in Davidson County North Carolina next Monday, April 26. The documents were faxed to Tennessee on April 7, but only arrived at my door yesterday.

It was requested by my wife and all the documentation is online, as well as my response via my daily voicemail which was done on video this time (http://family.kozlowski.org/Voicemail-2021-04-19).

You can see that she requested an "Ex Parte Domestic Violence Order of Protection" and it was denied. It is marked as "The plaintiff has failed to prove grounds for ex parte relief."

I am given 10 days to respond before the court hearing which is scheduled for 7 days after I received the summons. There is an inconsistency issue here.

What concerns me is the disinformation that my wife is using. For example in the "Additional Information" page she quotes me as "I don't care. My lawgiver is the Lord Jesus Christ". The full quote is:

If you want to make your case from state law, then simply I don't care. My lawgiver is the Lord Jesus Christ. Do you know about Him? Let me tell you a bit about Him. He is the creator of the universe and sustains it this very moment. He is the one who is the sole authority and sets down clear rules for us, His creation, to obey. He has made it easy by summarizing His commands into two very clear laws, to love Him and to love each other. I'm striving to live in obedience to Him. Please consider joining me. You promised you would.

I think it is obvious that the connotation that is left by how she quoted me gives a different idea than what I actually wrote. The full email is at: http://family.kozlowski.org/Email-2021-03-31+1

Even before this occurred, I was preparing my next step. I have a file prepared for a local printer to produce a postcard that can be seen at: http://kozlowski.org/Promise. The objective should be obvious. I that the link is bold and clear on the postcard and the image I suggest is profound. That is my wife's hand in mine and the photo was taken by my daughter which she used for her "Keeping the Promise" video which is also at the link. Everyone understood then what

was in that image. Today, ErikaLeigh denies Christ and my wife essentially does so in deed. I remain keeping the promise.

I have no plans to show up in court. I do plan on sending more DVDs and now postcards.

My family needs to know that this husband and dad is a follower of the Lord Jesus Christ. While there is sin in my past and present, there is also continuous repentance. This is the Lord's grace to me. There was a time I thought that was shared. Perhaps one day with at least some it will be shared again. I remain open to that.
