Subject: RE: DVD response

Mr. Cross,

Let me also start on a positive note, I am rather pleased at the depth of your email. As you requested, this is not an immediate response.

It is often a marvel to see the Lord's timing. As mentioned in recent voicemails, I have a stack of 250 postcards that were printed for free for me. That alone was an unexpected blessing. The plan is to send one a day to different parties. Obviously the first was to my wife yesterday. The second went in the mail and was picked up about an hour before your email arrived. It was to you.

Then, besides my own prayers, there are several others in prayer for our relationship. This morning two emails came from those in prayer with words of encouragement. Again almost exactly an hour before your email came a third arrived.

This should give you a bit of my frame of mind as I write.

Since there has been a good bit of time to do so, I have become a more intense student of the Bible and history, but mostly the Bible. The Lord's marvelous grace has become ever so clearer, as well as His sovereignty. I am in constant celebration that He holds me, as I do not have the strength to hold Him.

In my study there have been some words that I have dug deep into, such as "coward", and the related "fear" or "respect". "Coward" comes from the Greek "deilos" which is defined as timid, fearful, or faithless. It is seen in context in Matthew 8:26 and Mark 4:40 when after Jesus calms the storm He asks "*Why are you **afraid**? Do you still have no faith?*" Even the NASB has a note that "afraid" is "cowardly". When Jesus tells about the Holy Spirit in John 14:27, He commands us to do the opposite with "*Do not let your heart be troubled, nor let it be **fearful**.*"

Where it becomes all the more profound in Rev 21:8 "*But as for the **cowardly**, the faithless, the detestable, as for murderers, the sexually immoral, sorcerers, idolaters, and all liars, their portion will be in the lake that burns with fire and sulfur, which is the second death.*"

The "faithless" is simply the negation of the "believes" that we see in the often abused John 3:16. The cowardly end with the same result as those in the rest of the list, which is not a fine group. This should cause a serious amount of concern.

But then there is the marvelous grace of the Lord. The cowards on the boat during the storm are the Apostles who post the resurrection became remarkably bold in their faith. One of the verses I cling to is when Thomas sees the resurrected Christ and states "*My Lord and My God*" in John 20:28. I state the same.

While I was not a witness to the resurrection, there was a dramatic change in me the day the Buick went up in flames. A good friend, James Graveling, challenged me from Scripture about my attitude. I struggled over the verses he quoted and repented. I haven't looked back since. I know what it is like to be cowardly and can point to a list of things that I

can look back at with disgust. I also know about repentance from that and the fruits of that have been marvelous, and sometimes costly.

But fear is different, it is “phobos” where we get phobia. You can see “deilos” as fear that is based on a lack of trust, while “phobos” is a knowing fear or respect. I try to keep in mind the end of 1st Peter 3:15 “*gentleness and respect*” which is “phobos”. It is not the power of the person I am dealing with, but that he is made in the image of God that causes me to offer respect. It is also seen in Ephesians 5:33 where the “respects” is obviously an issue.

Then there is the Galatians 2 passage that I mention frequently where Paul calls out Peter publicly. In a real sense this is what James Graveling, my beloved brother, did to me 8 years ago. There was much in me that was cowardly and I was shown where I was wrong and repented. Several years after Galatians 2 was written, Peter wrote his almost final words noting Paul as “*beloved brother*”. I use the same terms of beloved brother about James Graveling. It is what I continue to seek with you, Render Caines, and Chris Bitterman. You have all been contacted via emails, postcards, and DVDs. I’m not going to give up.

I find the words you use fascinating when you state: “John, the enemy is crafty, as you know. There is some truth in almost every lie that he tells.” I did a video “**Deceived by the truth**” on November 29, 2017 that essentially used those words. We are on the same page on that.

But then you get into what I would call pragmatics or money related issues. First let’s perhaps get out of the way an issue that you have stated before about paying past due rent. The reason we had to leave the Polk County home was that the landlord wanted the house back. This is the second time events like this have happened and both times the owner moved in. While I don’t know without checking, I don’t think we were behind on rent. But either way, it was not the rent issue that caused us to leave.

While I do admit that your tone is a bit gentler than before, you are stating again that I essentially ignored the needs of my family. It leaves the impression of a guy sitting in front of a TV watching football and drinking beer while his family is starving. You know it was nothing like that. Difficulties, yes. But not what you are implying.

Did I blunder? Yes! A bunch, a lot, and often. Was it out of lack of care? Not at all.

There are really two issues here. Why did I get into this situation? And what was done right or wrong in the process.

An obvious analogy on the why question is what I have used before, Julian Assange and Wikileaks. As a reminder you once stated I should distance myself from him. Sometime later I started the ShofarLeaks project. While dormant, it remains. While there is so much here, rather than repeat it all, take note of the current situation. He is in a maximum security prison, which is termed as the UK’s Guantanamo Bay. He is under no charge, but held in isolation 23 hours a day and it is taking a mental toll on him. It is clearly driven by revenge and to set a model to dissuade others from doing the same. If he were to ever see freedom again, which I doubt, because of what has happened to him, he might be error prone.

I see that example and wonder about my own history. As I think about the events around Westar, which I have documented many times, it wasn’t the Westar events that was my great failure, but what I did afterward while striving to recover in Enterprise, AL. While this is the easiest to explain, there are numerous other examples. Now that I can look back on them, I think I have a clearer understanding of where I went right, and where I went wrong.

While obviously I need to make sure I don’t go wrong again, it is where I went right that often caused the greatest harm. For Madge’s birthday I did a video for her that perhaps is unseen (<http://family.kozlowski.org/2021-04-28+2>). In

it I dropped in another video that I also used in the April 26 voicemail. Denis Rancourt, a gentleman who I have gained a lot of appreciation for, described the issue behind why his scientific paper was censored. This is related to masks, and his point is basically that pride and self-interest will cause people to ignore evidence or truth.

This is what I have seen in so many ways, far beyond masks. You need to be part of the team, be in our club, or you need to be removed. If you point out evidence that what we do is unethical in some way, you have to be silenced. If you point out things that would help our team to be better in what we do, but reduce our income or power, you will be persecuted. As I have described, I am a repeat offender. Then what do you do to the offender that is a threat to your power? That is the Assange example.

You are not the only one who has brought up the funds issue, but will not address why I am in the situation in the first place. For many, addressing that issue could be more than uncomfortable. I have referred to “The Red Button Problem” which I will simply quote below.

In the summer of 2000, I asked a group of 100 people at a conference of spiritually committed people who would push a red button if it would immediately stop all narcotics trafficking in their neighborhood, city, state and country. Out of 100 people, 99 said they would not push such red button. When surveyed, they said they did not want their mutual funds to go down if the U.S. financial system suddenly stopped attracting an estimated \$500 billion-\$1 trillion a year in global money laundering. They did not want their government checks jeopardized or their taxes raised because of resulting problems financing the federal government deficit.

Our financial profiteering and complicity is not limited to aristocrats and the elites who do their bidding. Our financial dependency on unsustainable economics is broad, ingrained and deep.

While Fitts’s Solari, Inc. is focused on reducing the cost, I will claim that for the follower of Christ, you simply push the button in obedience to Christ. While not as big of a button, I have pushed it many times. But people don’t dare ask.

As to what I have done right or wrong in attempting to care for my family, consider what it is like for a man who has spent time in high profile or high profit situations and in general can find serious income without serious work and then to spend time grinding deer meat for a low wage instead.

Then consider the present day. Why would I continue in a position where I make literally half the income of a junior software developer? If I simply quit and take Social Security I would get a raise. Why would someone do that? Why would someone continue working 70+ hours a week when he didn’t have to?

For part of the answer one of the best lines someone told me who otherwise was interested in a potential lucrative investment was that I was “on the wrong side of the NSA”. But it has gotten a whole lot worse. For some years I state “the institution is not your friend” and describe that in some detail. But now I also address the institution that should know better, the church.

After many years of refinement I now have a simple statement that I can defend but have not found anyone in a paid position to take me on: “The Bible is true and the institutional church is a fraud”. There is now a video that makes the case on my website. Can you take me on?

That leaves us with issues. If what has put me out of many situations is a sinful man striving to be obedient to the Lord, then why am I rejected by those who claim Christ? For those who share that the Bible is true, why don’t they address my claims about the institution? Is it the Red Button? Will it cost them and therefore it is best ignored?

Then there is the issue of my current sin. Of late I have found physical challenges easy to take on. This week already I have done 32+ miles of aggressive walking. I am well into my goal of doing a million jumping jacks in five years. This Friday we might finally again take the hike up Big Frog Mountain, 11+ miles and a half mile up. For this 65-year-old, that stuff is easy.

However, getting out of bed in the morning to work on software that has a serious potential to be a blessing to those who are in difficult situations has become rather hard. It is simply I have not found anyone who cares. On the other hand, I do start each day doing 256 continuous jumping jacks.

I make a conscience effort to encourage others wherever and whenever. I did a video “Parakaleō ► Encourage, To Call Near” that meant a lot to me, but my sin remains. My focus should be based solely on my trust in the Lord, but I remain weak. The sin of theft, murder, homosexuality is a real problem, but to know the Lord and still have this weakness is still my sin and very little different from the others.

If you challenge me in money, your focus is on the world. If you challenge me on being obedient to Christ with encouragement, or calling near, then you are acting as a brother. Where is your focus?

Look at what you wrote. It should be clear that your focus is money, and then obedience to Christ. To make this work you make the money issue as of the utmost importance to be obedient to Christ. You have amplified what you think are my sins to state your case which is simply to accuse me of being bad. You state things like “You would not obey our Heavenly Father out of love and respect for him”. Do you know the cost of making false accusations, or has money clouded your understanding of the Scripture?

Be clear when you state “That court was instituted by God Himself”. The Lord is indeed sovereign and therefore man’s courts exist by His decree, but it is not His command to man to institute them. Rather, the courts exist due to man’s rejection of God. Even after centuries of rejecting God, Paul still writes about the shame of going to man’s courts in 1st Corinthians 6, which has been pointed out many times. But NO, you must turn to the state irrespective of the Lord’s commands. You trust the state to defend you rather than direct communications with a man who has been trying for years to do just that. Mr. Cross, your words are Christian like, but your deeds are very worldly, or as the Lord states directly a rejection of Him.

But then if you or Dorothy-Jane turn to the state, do you live by the state’s decree yourself? Clearly not. I am to know about my kids’ medical care and education. That has been hidden from me. I am allowed to talk to them multiple times per week. However, the excuse is they are being protected from me, therefore 1100+ voicemails unanswered. I am required to pay \$888 a month which includes paying for Julia, a mother with two kids already. This is simply called theft. But that is part of Exodus 20 which is so Old Testament that it clearly does not apply anymore as our Lord the state is the master, right?

You accuse me of not stepping up to the plate. I live in a 3 bedroom home and have invited my family or any of the kids to come. Consider the cost that is being paid by having two homes compared to one. When you divide a family and impose the state in between, it is not an issue of stepping up to the plate, it is that I don’t meet your definition of what is right. After all, it was you that stated that I should have at least an \$80k income to support my family. What verse did you use for that? Oh yes, the commandments of men from Mark 7:7.

You allude to 1st Timothy 5 for your justification and then tell me not to address that. You seem to be stating that you are obeying the Scripture, but don’t challenge you on the FACT that you are twisting the Scripture, just as you did with Matthew 19. I have ripped apart the use by you and Chris Bitterman of verse 8, but neither of you will address it from Scripture.

After years of study I now use the simple line that marriage begins with sex and ends with death. I have had the joy of taking on that challenge with many. Thus far I have been able to defend the position from Scripture to all challenges. At

least those who challenge from the Scripture and not the Talmud. Clearly, by your own words and deeds, you are not in agreement with me and thus far will not take on the challenge. You do a hit and run, but will not engage in serious dialog. This is what a man who is standing on sand would do. There is also another word.

I have stated before, Dorothy-Jane is my wife, and adulteress or dead. There is no other option in Scripture. Both you and Dorothy-Jane cannot defend your position, so you both run and hide.

You state that the problem is me and therefore until I change you will not engage me. It brings to mind a word again. You require my repentance as defined in your eyes, but have no idea about me. It is like you holding my head underwater and telling me to breathe. It is not a loving act.

Let me also remind you of your words one evening when you, Madge, Dorothy-Jane and myself were at a restaurant and you stated that if there were issues between Dorothy-Jane and myself, she was not invited back, but you would point her back to me. You did not keep that promise. Your dad did with Peter and Dale, but you simply did not and currently are not. That could change. Will it?

A bit on the technical front. For example I will mention the voicemail video which mentions you “**Call attempt #1,173 - Day 1,700 - Few women ever know this depth of love**” which is at: <http://family.kozlowski.org/Voicemail-2021-04-26>. Since that link is now in this email and you have a “LexcomInc.net” email address, it is now in the hands of Google since it is not Lexcom, but Google that hosts that email address. This is like my RapidRMS.com email address that is also hosted by Google, but unlike the Kozlowski.org email which is hosted by me.

Why does Google offer this service, and for many they offer it free? Because you are the product. This email will be electronically read by Google and they will use it for their search engine, advertising, and control, which is the greatest concern.

As I have pointed out, if you do a web search for “E System South” you will probably find links to either or both the Kozlowski.org or Family.Kozlowski.org sites. It is not because I have promoted it with Google, but because they read your email.

I have stated that if there is reconciliation and any of my kids have been provided cellphones, they will be discarded. I haven’t had one in years and I’m not that stupid to give them to my kids. The question is do you really know why not to have a cellphone?

This has become long, so let’s end with the obvious, is your Lord the one who describes Himself in the Bible? If so, then start again with Matthew 5:24 “*leave your gift there before the altar and go. First be reconciled to your brother, and then come and offer your gift.*” The priority is obviously our relationship over money. You have hours of videos to you and then days of videos to my family. There are emails galore to both. This is a model of a man seeking reconciliation. From you is what? Additional terms, issues about money, you are the victim, issues about money, and additional terms.

Consider the verse Galatians 4:16 “*Have I then become your enemy by telling you the truth?*” Did I write truth? Am I your enemy or your brother? Will you continue to ignore me, or will you respond?

As stated in the **Postcard Reconciliation** video, our day of death is approaching. There is evidence that I tried to reconcile. What is your legacy?

Good afternoon John,

Thank you for your DVD that I received this week.

This morning as Madge and I were praying I asked the Lord to show me how to love my neighbor as myself. Later as I thought about that I remembered that you had sent the DVD, and I determined to watch it. So now I have done that, and I do have a response.

First of all, I noticed your overall calm tone, and I appreciated that. I of course didn't appreciate being called a coward when I know that is not the truth. But, I do respect your privilege to use any wording you see fit. Not as rebuke, but just as a matter of fact from my standpoint - I don't think a coward would have agreed to take on the responsibility of the physical and monetary care of such a large family whose needs were not being met by their husband and father. Madge and I have had to totally revamp our retirement plans due to that undertaking, and let me quickly say that neither of us would shirk that duty if we had the opportunity to go back and leave them in that condition. "Condition" meaning having to lean on others for their most basic needs.

After moving the things from the home you were renting, I paid the past due rent to your landlord. They were extremely grateful, and we would do that all over again even if we were given the opportunity to have held on to those dollars ourselves.

I totally agree with you that there is much more evil in this world than there is good. The prince of the power of the air is the catalyst behind all that evil. I even agree that there is a lot of conspiracy behind the scenes in this dark world. But, I would suggest that the evil one is behind all of it. Marx, Hitler, Stalin, etc. were pawns in the hands of this evil one. And he will continue to find new pawns even as the old ones die out. So, is there a conspiracy? Absolutely!

John, the enemy is crafty, as you know. There is some truth in almost every lie that he tells. You've seen that I'm sure, and I definitely have seen that even in my own life. At times I have fallen for those lies, and you have as well. I will and do ask our Father to help me not to fall for the enemy's lies concerning you, and I would ask you to ask the Father the same concerning me.

I love your family deeply enough to allow my livelihood to be turned upside down. Am I perfect in that regard? Of course not. You would know that. But, I count it as my job - given to me by the Lord. I base that on two scriptures that I know you have heard from me numerous times. I'm clearly told that I must take care of the needs of others, especially those who are of my own family. I'm also told not to meet the needs of those who are clearly able to produce and will not do so. I know that your norm is to ridicule me for not using the scripture word for word. Please don't do that this time. You know both of those passages, and you know that I'm conveying the truth of their content in a way that is clearly understood.

Will you show that repentance by starting to more fully care for their physical needs? If your answer is, "No," why do you think we would stand idly by and give you access to their much deeper needs - their spiritual needs and their emotional needs?

I'm happy to tell you that those of your children who were not old enough to fully experience your neglect are doing quite well spiritually and emotionally. The others are struggling to get past that abuse of power or have - at least for a time - given up.

Please, John, think about them. They are precious. I'm not sure how they would respond to a truly repentant father, but I think it would go a long way toward helping them heal. Repentance is an act of turning from one thing and becoming a new person. Please, please show them you care in ways that they can tangibly accept. Why would you think that they would listen to any spiritual words - even if you mean well - when those words are truly coming from the one who spoke them long ago while you were abusing them with your disregard for their most basic needs?

I heard what you said about why you couldn't work for this company or that. But, those weren't the only jobs that you could have taken. So, don't use those instances to skirt the real issue. I think you deceived yourself over and over again. I think the true enemy of your family gave you lies with enough truth in them that you bought the lies. This is a call for you to spit those lies back into the face of the deceiver! You aren't the bad guy here, but you are the pawn of the great and powerful enemy of our Lord God Almighty! Please ask Him who bore your sins on the cross to open your eyes to any truth that He has spoken thru me. And ask Him where you should go from here.

In Jesus Name, I implore you to sit in front of Him with this email. Don't respond to it quickly. Take time to digest my words while in His presence. He can still use you, but probably not with your family, in your current condition.

Of course there are a few other things I would like to address, but from my perspective I think I have covered the most pressing issues.
