## Greetings,

A request was made by my wife on May 5, 2021 out of concern for "domestic violence" (<a href="http://family.kozlowski.org/Gov-2021-05-05+11">http://family.kozlowski.org/Gov-2021-05-05+11</a>), yet as documented (<a href="http://family.kozlowski.org/Gov-2021-05-14+1">http://family.kozlowski.org/Gov-2021-05-05+11</a>), yet as documented (<a href="http://family.kozlowski.org/Gov-2021-05-14+1">http://family.kozlowski.org/Gov-2021-05-05+11</a>), yet as documented (<a href="http://family.kozlowski.org/Gov-2021-05-14+1">http://family.kozlowski.org/Gov-2021-05-05+11</a>), yet as documented (<a href="http://family.kozlowski.org/Gov-2021-05-14+1">http://family.kozlowski.org/Gov-2021-05-14+1</a>) no such violence occurred or was threatened. No evidence of any has been presented.

While my wife's request was granted (<a href="http://family.kozlowski.org/Gov-2021-05-17">http://family.kozlowski.org/Gov-2021-05-17</a>) there remains no evidence that my appeal was heard (<a href="http://family.kozlowski.org/Gov-2021-05-26+1">http://family.kozlowski.org/Gov-2021-05-26+1</a>).

My wife has requested an additional two years (<a href="http://family.kozlowski.org/Gov-2022-04-12">http://family.kozlowski.org/Gov-2022-04-12</a>) and makes her case by pointing out things that I have the right to do under state laws that she agreed to.

She points out that I continue to call my kids. However, those calls are not answered and a voicemail is left. Those voicemails can be can be seen and heard at <a href="http://family.kozlowski.org">http://family.kozlowski.org</a> as I record those calls and they are public. This is my attempt to reconcile my family and break through the barriers that have been setup, contrary to the law, that have prevented calls to my kids for years.

So the law allows me to contact my kids by phone and send uncensored mail to them. My wife agrees that I call my kids, but refuses to allow me to talk with them. I have sent numerous postcards to my family and they have been returned as refused (<a href="http://kozlowski.org/Promise,Refused">http://kozlowski.org/Promise,Refused</a>), so my mail is censored in violation to the law.

Therefore it appears my wife appeals to the law, while showing no evidence that I have violated the law, but violates the law herself. She then is granted an order keeping me even further from my kids and now wants that extended for two more years.

It is my request that her appeal be denied. My only goal is reconciliation.
